

AM3264 – Filter Bank


Analog Tunable 103.0 to 191.0 MHz Lowpass

AM3264 is an analog voltage-tuned low pass filter with an adjustable corner between 103.0 and 191.0 MHz. AM3264 contains two different frequency bands, each controlled by a respective analog voltage input. Band 1 has a variable corner frequency between 103.0 and 145.0 MHz, and band 2 has a variable corner frequency between 130.0 and 191.0 MHz. The tunable low pass filter can be combined with one of Mercury’s tunable high pass filters to provide a flexible bandpass filter solution.



